(10) Management of Assets and Funds of Society

The sources of income of the society will include receipts on account of membership fee, annual subscription , rent from property/ assets, (i)interest, consultation fees, donation, gifts, grants, etc. The society can also raise funds through interest-fees short term loans form its members or from scheduled banks on interest. Loan from the scheduled banks on interest will be taken only for purchase of creation of capital assets and not for meeting any recurring revenue expenditure under any circumstances.

The Governing Body will prepare and approve an annual budget of

- (ii) the Society on the basis of its estimated income and the capital & revenue expenditure during the first quarter of the financial year and shall also place a copy thereof before the General Body in its Annual Meeting for information.
- (iii) The Bank account of the Society will be jointly operated by President, Secretary & Treasurer.
- (iv) All assets and funds will belong to the Society and vest in the society.
- All receipts and payments of the Society shall be made through Bank (v)Instruments (i.e. DD/Pay Order /Cheques/ Bank Transfers /RTGS) including all receipts towards the Membership Fees and annual subscription from the members. However, the Governing Body may determine the limits of financial transactions which may be conducted in cash in certain other cases.

(11) Accounts of the Society:
